**ORDINANCE NUMBER 12-1-2015**

**AN ORDINANCE FIXING THE TAX RATE FOR THE YEAR 2016**

BE IT ORDAINED AND ENACTED by the Council of the Borough of Corsica, Jefferson County, Pennsylvania, and IT IS HEREBY ORDAINED AND ENACTED by the authority of the same as follows:

1. That a tax be and the same is hereby levied on all real property within the same municipality subject to taxation for the fiscal year 2008 as follows:

Tax rate for general purposes, the sum of 8.0 mills on each dollar of assessed valuation.

Total	8.0 mills

2. That a tax rate be the same is hereby levied on all occupations within said municipality subject to taxation for the fiscal year 2016 as follows:

Tax rate for general purposes, the sum of 15.0 mills on each dollar assessed valuation.

Total	15.0 mills

3. That a per capita tax of \$5.00 be and the same is hereby levied upon all residents of the said municipality subject to taxation for the fiscal year 2016.

4. that a Local Service Tax (LST) of \$52.00 shall be and the same is hereby levied upon all wage earners employed within the Borough of Corsica earning greater than \$12,000.00 and subject to taxation for the fiscal year 2016.

\$5.00 of the LST for each and every wage earner subject to taxation shall be tendered to the Clarion-Limestone School District.


