

ORDINANCE #

**AN ORDINANCE OF THE BOROUGH OF CORSICA,
JEFFERSON COUNTY, PENNSYLVANIA, PROVIDING FOR TRANSFER
OF THE WASTE WATER FACILITY AND SANITARY SEWER SYSTEM
TO THE BROOKVILLE MUNICIPAL AUTHORITY**

WHEREAS, the Borough of Corsica desires to provide the best service for treatment of waste water to the residents of the Borough of Corsica and authorized users of the Corsica Borough Wastewater Treatment Plant; and

WHEREAS, it has become increasingly difficult to maintain and prepare all the documents required by the Department of Environmental Protection; and

WHEREAS, the Rules and Regulations of the Department of Environmental Protection are continually evolving and changing; and

WHEREAS, the Office of the Borough of Corsica is staffed only on a part-time basis; and

WHEREAS, the Borough of Corsica does not have the manpower and expertise to expertly and efficiently run the Corsica Borough Wastewater Treatment Plant and the Brookville Municipal Authority has said expertise; and

WHEREAS, the Brookville Municipal Authority has indicated their interest in owning, maintaining and operating the Corsica Borough Wastewater Treatment Plant;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of Corsica Borough, Jefferson County, Pennsylvania; and IT IS HEREBY ORDAINED AND ENACTED by the authority of the same as follows:

1. The Borough of Corsica hereby agrees to convey all right, title, interest and responsibility related to the Corsica Borough Wastewater Treatment Plant to the Brookville Municipal Authority.

2. The Borough of Corsica hereby agrees to convey to the Brookville Municipal Authority all real estate, rights of way, sanitary sewer lines, manholes, pumping stations, and all accouterments incidental to the collection and transportation of wastewater to the Wastewater Treatment Plant for treatment and discharge.

3. The Borough of Corsica hereby agrees to transfer all billing accounts, books of accounts, blueprints of the sanitary sewer system and attendant records to the Brookville Municipal Authority on a date to be agreed amongst the parties but which will

be the first date available to enable an efficient, smooth transfer of services to the Brookville Municipal Authority.

4. The Council of the Borough of Corsica hereby empowers its official representatives to execute all documents, including but not limited to, deeds, rights of way, agreements and/or contracts necessary to effectuate the transfer of the Corsica Borough Wastewater Treatment Plant and sanitary sewer system to the Brookville Municipal Authority.
